CCllr Jill Tavener reported that the Woodford Biomass facility was still in the process of submitting a planning application but this was likely to take some time. She also informed the meeting of a new facility available at the One Leisure building in St. Ives covering general health checks including blood pressure measuring. A member of the public commented that the builders working at West End were parking on the grass verge causing damage to it. Cllr Brown confirmed that when the building work was completed the verge would be reinstated. A representative of Engie reported on the progress regarding the planning application for Wyton development. The amended plans included significant changes with roads, housing type – less care homes and more family housing. The public consultation will take place early in the spring for submission in the autumn.
